Regulatory framework

The tourism regulatory framework at EU, national, regional or even local level may impose burden related to tourism regulations, rules, or administrative practices in various forms and its magnitude may depend on many factors (e.g. type and size of organisation, areas of activities, type of initiative, etc.).

In the table below we have indicated the most common natures of burden. A piece of regulation, rule or administrative practice may be:

- Ø **Too costly:** if it imposes disproportionate financial burden on those who are bound to comply with it.
- Ø **Unnecessary:** if it concerns activities that are not necessary to be controlled due to, for example, existing common practice, self-regulation by the industry or overlaps with other regulations/rules/practices.
- Ø **Too restrictive:** if it imposes control that is obstructive or restraining to the operations and activities of those who are bound to comply with it.
- Ø **Too excessive:** if it is a regulation, rule or practice that could be useful but it imposes extreme or disproportionately high level of control.
- Ø **Too complex:** if it is difficult to comprehend or difficult to comply with it, due to, for example, multiple combinations of rules, or too wide range of addressees, activities, and scenarios it applies to.
- Ø **Lacks transparency:** if it is difficult to comprehend and comply with it due to vague or ambiguous wording leaving room for various interpretation, or certain aspects or outcomes are not described fully or described in an inexplicit manner.
- Ø **Lacks protection:** if it is a regulation, rule or practice that could be necessary to protect certain interest groups but it does not provide sufficient control on the detrimental activities or scenarios it is supposed to protect against.
